## 2026 Residential LED Lighting Rebate Instructions

By participating in the We Save program, you can save energy and earn a rebate when you purchase qualifying, energy efficient LED lighting for your home.

### What rebate can I earn?

TYPE	REBATE	ELIGIBLE PRODUCTS
LED bulb	50% of price, up to \$5/bulb	general purpose (A15/19/21/23), reflector/flood (BR30/38/40, PAR16/20/30/38), candle, globe
LED linear T8 tube lamp	50% of price, up to \$5/lamp	linear T8 tube lamp (2 foot, 4 foot, 8 foot)
LED fixture	50% of price, up to \$15/fixture	downlight (recessed, pendant, surface mount), under cabinet, bath vanity, wall mount, security/flood light
Ceiling fan w/ LED light kit	50% of price, up to \$25/fan	ceiling mounted fan with 29-54" blades (must include LED light kit)
LED decorative string lights	50% of price, up to \$10/string	string lights with mini, C7, or C9 bulbs

### LED Lighting Facts

- LED stands for light emitting diode. It's more efficient and lasts longer than incandescent and fluorescent lighting. It also produces less heat, which makes it safer to use and can save you money on home cooling.
- LED lighting typically does not "burn out" and instead the brightness dims slowly over time.

### Rebate Qualifications and Program Rules

- Residential customers receiving electric service from the City of Buffalo are eligible for a rebate when they purchase LED bulbs, fixtures, linear T8 tube lamps, ceiling fans with LED light kits, and string lights.
- Rope/tape lights, battery-powered lights, garage lights, and ventilation/exhaust fans are not eligible for rebate.
- Eligible decorative string lights include products with mini, C7, or C9 bulb sizes only. String lights must be plug-in (not battery-operated or solar). Fairy lights are not eligible for rebate.
- Rebate forms must include: (1) Rebate Application and (2) dated sales receipt. Incomplete applications will not be processed.
- Information on Rebate Application must match sales receipt.
- Customer must apply for rebate within one year of the purchase date shown on the sales receipt.
- Rebated bulbs and fixtures may not be used for resale.
- Limit one rebate per customer account per year. Total rebate limit of \$400 paid to customer.
- Rebate requests are processed on a first-come first-serve basis. Annual rebate funds are limited. Rebate programs, qualifications, and amounts are subject to change at any time.
- Qualifying customers must apply for rebate by November 30, 2026.
