- No one spoke at **open forum**.
- Approved a **temporary, on sale liquor license** for an event at Hayes' Public House March 14 – 17, 2025.
- Authorized submission of a **municipal cannabis retail operator license application** for the City of Buffalo.
- Approved the final design and **authorized advertisement bids** for the **Phase 2 expansion of Buffalo Fiber**.
- Scheduled a **public hearing on issuance of abatement bonds** for the **Phase 2 expansion of Buffalo Fiber**. The hearing is scheduled on Monday, March 17 at 7:00 PM.
- Approved a proposal from H+U Construction to provide **construction manager at risk** services for the renovation of the former "PenRad" building into a **community center**.
- Appointed **Benjy Schirm** to the **Community Center Advisory Board**.
- Rejected **bids** for the construction of an **electric substation transformer** and authorized re-bidding the project.
- Approved a **cooperative agreement** with Wright County for the **reconstruction and turnback** of a portion of **Count State Aid Highway (CSAH) 35**. This project would be completed in conjunction with the proposed **redevelopment of the former Wright County Government Center**.
- Appointed **Joshua Kent** to the **Finance Director/Assistant City Administrator** position.
