2025 Decorative LED String Lights Rebate Instructions

By participating in the We Save program, you can save energy and earn a rebate when you purchase qualifying, energy efficient LED string lights for your home.

What rebate can I earn?

LED decorative string light: 50% of price, up to \$10/string

What types of decorative string lights are eligible for rebate?

- LED string lights with mini, C7, or C9 bulb sizes are eligible for this rebate. These bulbs come in a variety of colors and can be faceted or smooth.
- Mini bulbs are small, candle-shaped bulbs with a pointed tip and are typically used indoors.
- C7 and C9 bulbs are strawberry-shaped bulbs. These bulbs are larger than mini lights and increase in size from C7 to C9. They're typically used outdoors.



LED Lighting Facts

LED stands for light emitting diode. LED string lights are more efficient, using about 92% less energy than traditional incandescent string lights. They don't have moving parts, filaments or glass, so they are more durable and shock-resistant than traditional string lights. They also produce less heat, which makes them safer to use.

Rebate Qualifications and Program Rules

- Residential customers receiving electric service from the City of Buffalo are eligible for a rebate when they purchase decorative LED string lights.
- Eligible string lights include products with mini, C7, or C9 bulb sizes only. String lights must be plug-in (not battery-operated or solar). Rope and fairy lights are not eligible for rebate.
- Rebate forms must include: (1) Rebate Application and (2) dated sales receipt. Incomplete applications will not be processed.
- Information on Rebate Application must match sales receipt.
- Rebated string lights may not be used for resale.
- Limit one rebate per customer account per year. Total rebate limit of \$400 paid to customer.
- Rebate requests are processed on a first-come first-serve basis. Annual rebate funds are limited. Rebate programs, qualifications, and amounts are subject to change at any time.
- Qualifying customers must apply for rebate by December 31, 2025.
